Active use is assessed for the calendar month that precedes the month for which the flat-rate fee is paid.	Footnote 1) For EXKLUZIVNÍ účet, it means that the sum of deposits and investments of the account holder (deposits mean the sum of positive balances of accounts and term deposits; investments are considered as the price of investment instruments under the bank's management), being in the position of a consumer, held with the bank as of the last day of the month amounts to at least 1,500,000 CZK (or an equivalent amount in another currency) or incoming payments in the total amount of at least CZK 50,000 will be credited to the account per month. However, incoming payments will they only count the amounts of the two incoming payments with the highest amount in the month. Incoming payments shall not include incoming payments from any current or savings accounts of the same holder, transfers from term deposits to the account, transfers between currency elements of the account, credited interest or incoming/reverse card transactions. Active use is assessed for the calendar month that precedes the month for which the flat-rate fee is paid.
